Srihari ,Director, M/s Sipra Labs Ltd. and the Government of Andhra Pradesh (hereinafter referred to as "GoAP"), represented by Shri Kartikeya Misra, IAS, Director of Industries, Government of Andhra Pradesh for establishing the following project.
